Reef Daytripper is committed to improving and sustaining the efforts of local businesses and organisations where we are able to, so we can contribute economically and socially to the local community. We recognise that Upolu Reef is of great importance to local indigenous groups and firmly believe that recognising and educating visitors and locals of their ongoing connection to the Great Barrier Reef is key to maintaining cultural sustainability.

At Reef Daytripper we firmly believe that a community that works together, thrives together and provides an environment that can be enjoyed by locals and visitors alike, and one that cohesively offers a world-class experience.

Key components of our commitment to social and cultural sustainability include:

- Prioritising the health and well-being of our crew and guests via policies and planning that ensures we meet a high standard of safety at all times.
- Maintaining strong relationships with membership organisations, local councils, peak tourism bodies and government bodies to ensure we maintain a high level of safety and customer service.
- Actively engaging with local businesses to maintain our daily operations, and to ensure we are supporting local suppliers.
- Supporting community groups and businesses through charitable donations.
- Recognising the correct indigenous groups and acknowledging their connection to Upolu Reef.

PRIORITISING THE HEALTH AND WELL-BEING OF OUR CREW AND GUESTS VIA POLICIES AND PLANNING

Reef Daytripper conducts an annual review of all policies and procedures within our Safety Management System to ensure our policies and procedures are compliant with WorkSafe Queensland, The Great Barrier Reef Marine Park Authority, and the Australian Maritime Safety Authority. We also conduct regular drills, on at least a monthly basis to prepare in the event of reasonably foreseeable incidents including:

- Fire
- Man Overboard
- Steering loss
- Missing diver/snorkeller
- Unconscious diver/snorkeller
- Suspected DCS (decompression sickness)

Our crew are required to have the following licenses/certificates in order for them to work as PADI dive instructors:

- PADI OWSI or higher
- In current teaching status
- Current occupational dive medical - AS2299
- Current O2 & first aid certificates
- 2 to 3 years of Dive industry experience
- Sailing experience
- Excellent sales & customer service skills
- Works well in a team.
- High-Level English language skills required.
- Certificate II in Maritime Operations (Coxswain Grade 1 Near Coastal Skippers Only).

All our crew are afforded the opportunities for ongoing professional development, and to obtain the Certificate II in Maritime Operations (Coxswain Grade 1 Near Coastal) certification.

To ensure all aspects of our service are carried out with professionalism and safety in mind, we hold and maintain the required food licence issued by the [Cairns Regional Council](#) and compelled by [Section 48 of the Food Act 2006](#) and [Food Safety Standard 3.2.2A](#)



As a dive and snorkel operator in Queensland, Reef Daytripper must comply with the [Safety in Recreational Water Activities Regulation 2024](#) and the [Recreational Diving, Recreational Technical Diving and Snorkelling Code of Practice 2024](#) as required by Workplace Health and Safety Queensland. These also provide us a framework and set of guiding principles that help us to ensure the health and safety of our crew, contractors and guests alike while we conduct our daily operations.

As a commercial vessel Reef Daytripper must comply with the Australian Maritime Safety Authority regulations, under the [National Standard for Commercial Vessels](#). This provides minimum standards for vessel design, construction and equipment required to ensure the health and safety of all persons travelling with Reef Daytripper.

Reef Daytripper owns and maintains several moorings at Upolu Reef, where our permits restrict us to. As required by the [Great Barrier Reef Marine Park Authority](#), we must only conduct the approved activities specified within our permits and zone which we operate. As Upolu Reef is in a Marine National Park zone, we can only conduct approved boating, diving, photography, and research with any fishing netting and collecting marine life strictly prohibited.

Reef Daytripper crew actively participates in the [Eye on the Reef](#) programs including reef health and impact surveys, weekly monitoring surveys, along with reporting any marine life sightings of interest. The Eye on the Reef programs serve as an important data collection method that aims to preserve the Great Barrier Reef and ensure its long-term protection. The tourism program we conduct as per the parameters of our permit's places a duty on us to be custodians of the reef and ensure that all our guests leave with knowledge of the environment and are educated on the potential and current threats to the reef.

To ensure that our valued guests are fully informed before joining our tour, we provide an [accessibility self-assessment guide](#) on our website so that they can check to see if our facilities can service their needs.



CULTURAL SUSTAINABILITY

Upolu Reef is part of the traditional sea country of several indigenous groups, who are recognised as the traditional owners with their own specific interests in the area. The traditional owners include the following groups:

Yirrganydji (Irukanjdji) people: Saltwater Aboriginal people whose country extends along the coast from Cairns to Port Douglas.


Mandingalbay Yidinji people: Custodians of land and sea country that includes areas across the water from Cairns, extending to the reef.

Gungandji people: traditional owners of the coastal area around Yarrabah and offshore islands.

Reef Daytripper recognises the thousands-of-years-old connection to Upolu Reef held by traditional owners and their ongoing traditional management. Upolu Reef and the surrounding sea country form part of a broader cultural landscape and the connection to history, dreaming stories, and traditional knowledge.

Today, the Yirrganydji and Mandingalbay Yidinji peoples conduct hunting, fishing and other traditional activities under Traditional Use of Marine Resources Agreements (TURMAs). Members of these groups are actively involved in monitoring reef health, conducting research, and managing the area as part of the Great Barrier Reef Marine Park.

Reef Daytripper includes an acknowledgement of country on our website and in onboard materials our tour to foster respect and recognition.
